Notice Inviting Tender

The High Commission of India invites sealed tenders from experienced companies for supply and installation of CCTV system in Consular Hall (ground floor) and Chancery (6<sup>th</sup> floor) at LIC Building, Port Louis. The specific conditions of tender are: a) Execution of job on turn-key basis; b) Earnest money of amount MUR. 3000.00; c) Payment plan (Advance: 10%, Delivery of goods: 30%, Completion and start-up: 50% and Retention: 10% (2 months of date of hand over) (Plan negotiable). The guarantee period should be one year (date of hand over) with free replacement of defective equipment immediately during the guarantee period. The company should provide operational training to officials in Chancery.

The tender should be submitted in two separate sealed envelopes. The first envelope should contain the details of qualification, past experience of the company and name of satisfied clients. The second envelope should clearly mention the amount and time required for completion of work along-with the details of the work and type of equipment / hardware with quantity.
