



Terms and Conditions for Millets Quiz on Facebook Page of the High Commission of India in Mauritius

1. The quiz on Millets is open to residents of the Republic of Mauritius and Indians residing in Mauritius aged 18 years or over, except employees of the High Commission of India and their close relatives, and anyone otherwise connected with the organisation.
2. Entry to the quiz is free of charge and no purchase is necessary.
3. By entering this quiz, an entrant is indicating his/her agreement to be bound by these terms and conditions.
4. The quiz will run on Facebook from 27th February 2023 to 6th March 2023, inclusive. Any entries received after this time will not be considered.
5. The rules of the quiz and how to enter are as follows:
 - a) The quiz will consist of 20 questions about millets.
 - b) Entrants must answer all questions in the quiz correctly to be eligible for the prize.
 - c) To enter, participants must complete the quiz and submit their answers along with their name and phone number in the submission form provided.
6. Only one entry per person is permitted. Multiple entries from the same person will be disqualified.
7. The High Commission of India in Mauritius reserves the right to disqualify any entry if it has reasonable grounds to believe that the entrant has breached any of these terms and conditions.
8. The winners will be chosen at random from all correct entries received and will be announced on Facebook within 7 days of the quiz closing date.
9. The prize is as follows:
 - a) Three winners will be chosen at random from all eligible entries received.
 - b) Each winner will receive a gift hamper from Mantra Foods.
 - c) The prize is as stated, and no cash or other alternatives will be offered. The prizes are not transferable. Prizes are subject to availability, and we reserve the right to substitute any prize with another of equivalent value without giving notice.
