INVITATION TO TENDER

1. The High Commission of India, Port Louis for and on behalf of President of India, invites lump-sum tenders from reputed agencies/ contractors registered/ authorized for undertaking water proofing works in Mauritius for the following works:

Water Proofing treatment of Roof and terraces of the Indira Gandhi Center for Indian Culture, Phoenix, Port Louis	

2. Agencies/ contractors who fulfill the following requirements shall be eligible to apply. These criteria are indicative. Exact details are available in tender documents.

(i) Experience of having satisfactorily completed three similar works, each costing not less than MUR 1,000,000.00 or two works each costing not less than MUR 1,500,000.00 or one work costing not less than MUR 2,000,000 (excluding tax/VAT) during the last 7 years up to the last date of submission of tenders.

(ii) Should have average annual financial turnover of not less than MUR 1,250,000.00 (excluding VAT) on water proofing and /or construction works during the immediate last three consecutive financial years.

(iii) Bidding company should not have incurred loss in more than two years during the last five financial years, including in the last financial year.

(iv) Should have a bank solvency of Euros MUR 1,000,000.00 as per details in tender.

Cheques shall be drawn in favour of **High Commission of India, Port Louis**.

4. The last date of receipt of application to purchase tender documents will be on **07th April, 2017**(5 days before last date of submission of tenders) up to 4.00 PM.

5. **Tender Security/Bid Security /Earnest Money Deposit:** The Applicant must submit with his Tender the Tender Security/Bid Security / Earnest Money Deposit (EMD)/Tender Bond in the sum of MUR 50,000.00 at the time of submission of bids. Tender Security/Bid Security/ EMD/Tender Bond shall be acceptable by bank transfer/bank draft/pay order in favour of **Head of Chancery, High Commission of India, Port Louis** or bank guarantee (as per enclosed proforma in Tender Document). The other terms and conditions related with the EMD/Tender Bond shall remain same as mentioned in the tender document.

The tender security /EMD / Tender Bond shall remain valid for a period of One Hundred Eighty (180) days from last date of submission of tender.

6. Tender documents supported with prescribed annexures should be submitted in sealed envelope, duly superscribed with the name of work and the date of opening. The document will be received up to 3.00 PM on **Thursday 13th April, 2017** and technical bids will be opened on the same day at 3.30 PM.

7. If any information furnished by the applicant is found incorrect at a later stage, he/she shall be liable to be debarred from the tendering process. The High Commission of India, Port Louis reserves its right to verify the particulars furnished by the applicant independently.

8. The High Commission of India, Port Louis reserves the right to reject any prospective applicant without assigning any reason and to restrict the list of prequalified contractors to any number deemed suitable by it.
